

# MAMA BARE BEAUTY SERVICE AGREEMENT

THIS SERVICE AGREEMENT IS DATED BY AND I	BETWEEN MAMA BARE BEAUTY AND
("CLIENT")	
MAMA BARE BEAUTY AND CLIENT WILL BE REFERRED	TO AS "PARTIES" COLLECTIVELY.
THE PARTIES AGREE TO THE FOLLOWING T	FRMS AND POLICIES:

1. BOOKINGS: TO SECURE A DATE, A SIGNED CONTRACT IS REQUIRED WITH A DEPOSIT OF \$25 PER SERVICE. THE DEPOSIT IS NON-REFUNDABLE. A 10 DAY GRACE PERIOD, STARTING DAY OF DEPOSIT, WILL BE IN EFFECT. ALL CHANGES MADE TO THE AGREED UPON INVOICE SHOULD BE MADE ON OR BEFORE THE 30 DAYS BEFORE THE EVENT. STARTING 30 DAYS BEFORE THE EVENT DATE ALL FINAL DEATAILS MUST BE FINALIZED, THE CLIENT ONLY DOES HAVE THE ABILITY TO CHANGE THE DETAILS OF THEIR SERVICES AFTER THE 30 DAYS CUT OFF ONLY IF THE TRIAL SESSION HAS NOT OCCURED.

2. CONSULTATION / TRIAL: A TRIAL MAKEUP AND HAIR SESSION (CONSULTATION) IS AVAILABLE AND INCLUDED IN THE BRIDAL PACKAGE. A TRIAL SESSION WILL ONLY BE SCHEDULED ONCE DEPOSIT IS PAID AND SERVICE AGREEMENT IS SIGNED AND RETURNED. ANY OTHER TRIAL SESSIONS WANTED WILL BE CHARGED AS FULL PRICE. THE MAKEUP LOOK AND HAIRSTYLE RECIEVED AT THE TRIAL MUST BE THE DESIRED LOOK FOR THE SCHEDULED EVENT. IF THE CLIENT WISHES TO OBTAIN A MAKEUP AND HAIRSTYLE ON THE DAY OF THE TRIAL DIFFERENT THAN WHAT WILL BE DESIRED AT THE SCHDULED EVENT THE CLIENT WILL BE EXPECTED TO PAY FULL PRICE FOR THAT SERVICE AND RESCHEDULE A TRIAL FOR THE ACTUAL EVENT LOOK. THE CLIENT MUST INFORM MAMA BARE BEAUTY OF DESIRED CHANGES TO THE LOOK AT LEAST 30 DAYS BEFORE THE SCHEDULED SERVICE IN WRITING. NO CHANGES CAN BE MADE TO THE INVOICE ON OR AFTER 30 DAYS PRIOR TO THE SCHEDULED DATE OF SERVICE. IF A CANCELLATION OCCURS WITHIN THOSE 30 DAYS THE FULL SERVICE AMOUNT IS TO BE PAID.

ALL TRIALS MUST BE BOOKED MONDAY - THURSDAY. IF THE CLIENT REQUESTS A WEEKEND (FRIDAY-SATURDAY) APPOINMENT FOR A TRIAL THEN FULL PRICE OF THE SERVICE RECIEVED WILL BE CHARGED, NO TRIALS WILL BE BOOKED ON SUNDAYS.

ALL TRIAL APPOINTMENTS ARE BOOKED FOR 2 HOURS, IF THE APPOINTMENT GOES BEYOND THE 2 HOUR TIME LIMIT DUE TO CHANGES REQUESTED FROM THE CLIENT A FEE OF \$50/ HR WILL BE APPLIED TO THE FINAL COST. IF THE CLIENT WOULD LIKE TO SCHEDULE MORE THAN 1 TRIAL SESSION, THE SECOND SESSION WILL BE CHARGED THE FULL AMOUNT FOR SERVICES. THE 1ST SESSION IS INCLUDED IN THE BRIDAL PACKAGE ONLY.

CLIENTS ARE EXPECTED TO TRAVEL TO THE ARTISTS FOR THE TRIALS. IF THE MAKEUP OR HAIR ARTIST TRAVEL TO THE CLIENT FOR A TRIAL, A TRAVEL FEE OF \$50 PER SERVICE PROVIDER WILL BE REQUESTED AT THE TIME OF TRIAL. TRIAL TRAVEL FEES APPLY REGUARDLESS OF THE CLIENTS LOCATION.

#### MAMA BARE BEAUTY SERVICE AGREEMENT

3. CANCELLATION POLICY: IF MAMA BARE BEAUTY CANCELS AT ANYTIME OR IS UNABLE TO PERFORM THE SERVICE FOR ANY REASON OTHER THAN LIFE ALTERING EVENTS SUCH AS BUT NOT LIMITED TO, DEATH, ILLNESS OR NATURAL DISASTERS. THIS SERVICE AGREEMENT BECOMES INVALID. IF ANY PARTY OF THE SCHEDULED EVENT CANCELS ON OR AFTER 30 DAYS PRIOR TO THE SCHDULED EVENT, THE CLIENT IS RESPONSIABLE FOR THE FULL AMOUNT OF THAT INDIVIDUAL AND SHOULD BE PAID BEFORE OR ON THE DATE OF SERVICE. IF CANCELLATION, OCCURS AFTER THE 10 DAY GRACE PERIOD AND MORE THAN 30 DAYS PRIOR TO THE SCHEDULED EVENT 60% OF THE TOTAL COST OF THE CLIENT SHALL BE PAID TO MAMA BARE BEAUTY BY THE CLIENT ON OR BEFORE THE EVENT DATE. IF CANCELLATION OCCURS ON OR AFTER 30 DAYS PRIOR TO THE EVENT DATE THE CLIENT IS RESPONSIBALE FOR THE FULL AMOUNT QUOTED AND AGREED UPON FOR ALL PARTIES. THIS AMOUNT SHOULD BE PAID ON OR BEFORE THE ORIGINAL SERVICE DATE OR THE CANCELLATION WILL NOT BE VALID. THE EVENT DATE IS ALLOWED TO BE CHANGED ONLY ONCE, AFTER THAT A FEE OF \$75 WILL BE APPLIED FOR EVERY DATE CHANGE, IF MAMA BARE BEAUTY IS NOT AVAILABLE ON THE NEW DATE CHOSEN AND A CANCELLATION MUST OCCUR, THE CLIENT MUST PAY AN EARLY CANCALLATION FEE OF \$200 TO MAMA BARE BEAUTY. PAYMENT MUST BE MADE ON OR BEFORE THE ORIGINAL EVENT DATE OR THE CANCELLATION IS NOT VALID. ALL ATTEMPTS SHOULD BE MADE TO SELECT A NEW DATE SASTIFACTORY FOR BOTH PARTIES BEFORE A CANCELLATION CAN OCCUR. IF THE EVENT IS CANCELLED DUE TO AN UNFORSCEEN LIFE ALTERING EVENT, SUCH AS DEATH, CRITICAL ILLNESS OR NATURAL DISASTER, A PENALETY FEE OF \$200 SHALL BE PAID BY THE CLIENT TO MAMA BARE BEAUTY AND THE AGREEMENT SHALL BE TERMINATED DESPITE THE DATE OF THE SCHEDULED EVENT, PROPER DOCUMENTIATION AND PROOF OF CANCELLATION CAUSE MUST BE MADE BEFORE CANCELLATION CAN OCCUR.

4. PAYMENT: THE CLIENT IS REQUIRED TO PAY MAMA BARE BEAUTY THE REMAINING BALANCE AS ONE FULL PAYMENT WITH NO EXCEPTIONS. ACCEPTABLE FORMS OF PAYMENT: PAYPAL OR CASH THE CLIENT UNDERSTANDS THAT THERE MAY BE A PROCESSING FEE APPLIED WHEN USING PAYPAL AND IS FINANCIALLY RESPONSIBLE FOR THEMSELVES ALONG WITH ALL RECIPIENTS OF SERVICE FOR THE FEE AND ALL SERVICES COMPLETED AT THE SCHEDULED EVENT.

AN INVOICE WILL BE PROVIDED TO THE CLIENT AND BOTH PARTIES SHALL SIGN AND AGREE TO THE

AN INVOICE WILL BE PROVIDED TO THE CLIENT AND BOTH PARTIES SHALL SIGN AND AGREE TO THE REMAINING BALANCES. THIS INVOICE SHALL STAND AS PROOF OF AGREED UPON COSTS FOR THE SCHEDULED EVENT RELATED TO THIS SERVICE AGREEMENT.

5. TRAVEL AND LOCATION: CLIENT UNDERSTANDS THAT A LOCATION FEE MAY APPLY TO THE FINAL BALANCE DEPENDING ON THE LOCATION OF EVENT AND DISCRETION OF THE ARTISTS. THE LOCATION FEE MAY INCLUDE (BUT IS NOT LIMITED TO) TRAVEL COSTS SUCH AS: AIRFARE, HOTEL, TRANSPORTATION, PARKING, AND SERVICE INCIDENTALS.

A TRAVEL FEE OF <u>\$50</u> PER SERVICE WILL BE APPLIED AN FOR EVENT OUT SIDE OF <u>MONTGOMERY</u>

<u>COUNTY</u>. IF TRAVEL TO A TRIAL IS NEEDED THE CLIENT SHALL PAY

<u>\$50</u> PER SERVICE AT THE TIME OF TRIAL.

IF THE EVENT VENUE MORE MORE THAN <u>2 HOURS (BY CAR)</u> AWAY FROM THE STUDIO LOCATION THEN LODGING ACCOMADATIONS MUST BE PROVIDED AT THE EXPENSE OF THE CLIENT FOR MAMA BARE BEAUTY ARTISTS.

6. PHOTO/VIDEO CONSENT: PHOTOS TAKEN AT THE CONSULTATION, TIME OF SERVICE, OR EVENT MAY BE USED BY MAMA BARE BEAUTY FOR ADVERTISING AND MARKETING, PORTFOLIOS, TRAINING, AND OTHER USE.PHOTOS ARE ALLOWED TO BE POSTED ON SOCIAL MEDIA PLATFORMS WITHOUT CREDIT. MAKEUP ARTIST AGREES TO GIVE ANY PHOTOS TAKEN BY A PROFESSINAL PHOTOGRAPHER PROPER CREDIT IF THE INFORMATION IS RECIEVED.

### 7. LIMITATION ON LIABILITY:

- A. CLIENT RELEASES MAMA BARE BEAUTY OF LIABILITY FOR ANY CLAIM, LOSS, DAMAGE, OR INJURY TO ANY PERSON OR PROPERTY ARISING, EITHER DIRECTLY OR INDIRECTLY, FROM SERVICES PREFORMED.
  - B. MAMA BARE BEAUTY GUARANTEES THAT ALL BRUSHES, TOOLS, AND MAKEUP PRODUCTS ARE KEPT SANITARY AND ARE SANITIZED BETWEEN EVERY MAKEUP APPLICATION.
- C. CLIENT IS RESPONSIBLE FOR REPORTING ANY SKIN CONDITIONS, SENSITIVITIES, OR ALLERGIES PRIOR TO APPLICATION. INCLUDING ANY HISTORY OR CURRENT OUTBREAK OF CONTAGIOUS VIRUSES SUCH AS HERPES SIMPLEX VIRUS. CLIENT UNDERSTANDS THAT A PATCH TEST IS AVAILABLE UPON REQUEST TO TEST FOR A REACTION. CLIENT AGREES TO RELEASE MAKEUP ARTIST FROM LIABILITY FOR ANY SKIN, EYE, OR ORAL COMPLICATIONS DUE TO ALLERGIC REACTION OR SENSITIVITIES.
